Subject: Addition of new clauses to the Notice Inviting Tender (NIT). Ref. E-Tender No: RFCL-2025-235 for Annual Rate Contract for the Operation, Upkeep, and Maintenance of the Factory Central Canteen at RFCL Ramagundam.

With reference to the above-mentioned tender published on 07.02.2026, all prospective bidders are hereby informed that the following additional clauses are being incorporated into the NIT. These additions shall form an integral part of the Tender Document.

Additions to the NIT Clauses:

Clause Ref.	Subject	Amended / Additional Provision
New Clause No. 09	BIDS EVALUATION CRITERIA	Bidder's bid should be workable, and price bids quoting contracts service/profit margin less than 3.85% for the supply of manpower on pre-filled value of RFCL will be outrightly rejected. In case, after Price Bid evaluation & analysis, it is found that bids have been submitted with non-workable rates, i.e. service margin less than 3.85% for SoR or abnormally high rates for SoR, such offers may be rejected.
New Clause No. 10		Evaluation of the price bids shall be on an overall basis, and work shall be awarded to the L-1 bid.
New Clause No. 11		If the SOR Service Charges/Profit Margin/ Administrative Charges quoted by two or more bidders are happened to be the same, those bidders will be given a stipulated time period in which they have to submit a closed envelope quoting the percentage of discount on their previously submitted SOR Service Charges/Profit Margin/ Administrative Charges. The bidder who offers the highest percentage of discount will be awarded the contract. Further, if two or more bids after discount also happens to be the same, the lowest bid will be selected based on a draw/lottery system among these bids. Bidder shall ensure that after considering the discount offered, the overall quoted rate shall remain greater than or equal to +3.85% for SoR.
New Clause No. 12		The rates to be quoted by the party should be inclusive of all duties, taxes, levies, entry tax, etc., but excluding GST. The GST will be extra and as applicable.

All other terms and conditions of the original NIT remain unchanged.
